Guidelines and Application Form

Twice a year council calls for applications from Clubs/Organisations/Individuals requiring Council Assistance in the coming financial year.

Organisations are to note that Council, when providing assistance will not provide direct cash contributions but will enable the provision of in-kind support only (no direct cash donations).

"IN-KIND" support generally means a provision of goods or service, a waiver of fees etc and will not be a direct cash contribution. Assistance is divided into Waiver of fees/In-Kind Assistance from Council and Other.

The following local organisations will be eligible for assistance under this policy: -

- ♦ Charities
- Not for Profit or Religious Organisations
- ♦ Sporting or Hobby Groups / Bodies

Council shall determine what "in-kind" assistance shall be provided to each applicant when framing its' budget for the coming year.

In determining the level of assistance required, Council shall: -

- > Establish the level of funding available in terms of its' coming budget requirements;
- Apportion such funding across each application eligible for funding.

Council shall have sole discretion in determining the type and level of support to be provided to each applicant.

It shall not be the policy of the Council to prioritise the needs of one applicant against another in determining the level of support, except that the applicant must be an eligible applicant in terms of the above eligibility criteria.

Notification of the assistance to be provided by Council shall be undertaken as soon as practicable after Councils' meeting.

When successful, the applicant MUST contact Council to organise assistance and quote the job number provided in letter.

Applicants requiring assistance under this policy must fill in the information requested in the application form and complete all sections necessary marked with an *

Applications Close 2 June 2023

Applications received after the advertised closing date may not be considered for assistance by Council in the coming financial year.
